

AMERICAN LIBRARY IN PARIS

The American Library in Paris, founded in 1920, is one of the oldest private American cultural institutions in Paris and the largest English-language library in continental Europe. It is a non-profit membership institution open to English readers of all nationalities.

The goals of the founders, to which the American Library in Paris continues to subscribe, were:

- To establish and maintain in Paris and elsewhere a library of books, periodicals and newspapers in English.
- To aid in the international exchange of information about books, libraries and library methods.
- To promote cordial relations between France and the United States through mutual association in library service.
- To provide for the English-speaking community of Paris the essential services of an American library.

Circulation, reference, photocopying, microforms, and access to the Reading Room are available to members. These services, with the exception of borrowing privileges, are available to non-members for a daily or six-month user fee.

Reference books, general fiction and non-fiction, and children's books.

Periodicals and indexes.

Audio recordings.

Microforms (including the complete International Herald Tribune, on microfilm, from its founding in 1887).

REPORT OF THE CHAIRMAN

After all the excitement and the non-stop activity of 1991 – the successful fund-raising campaign for our new Research Center and the Library existing as part "chantier" during the six months of its construction – 1992 was a year of quieter projects and reflection, a year to set objectives and goals to ensure the Library a firm base on which to go forward into the 21st century. This involved a lot of meticulous, behind-the-scenes activity such as revising the Library's Statutes and By-laws (which had not been done since the 1950's!) and re-negotiating our different agreements with the American University Library. A professional study was also done to make recommendations for the Library to use in establishing these much needed goals and objectives for the future. These on-going projects were all begun in 1992 and will not be completed until 1993. I would like to thank particularly the following Trustees for their hard work on the above projects: Virginia Pilpoul, Catherine Coste, Guy Dunham, Jack Anderson, Bob Gogel and Dr. Brooke Sheldon.

One of the highlights of 1992 was the prestigious opening and ribbon-cutting ceremony for the new Research Center held on April 2, 1992. Mary Walton Curley, U.S. Ambassador Walter J.P. Curley's wife, officially opened the new center by cutting the ribbon in the presence of many of the Research Center's distinguished donors or their representatives which included: Mr. F.H.S. Allen of J.P. Morgan Charitable Trust; Mr. Freddy Dressen of the Florence Gould Foundation; Mrs. Linda Emmet of the Irving Berlin Charitable Trust; Mr. Eric Boissonnas of the Scaler Foundation; and Mrs. Reginald F. Lewis of the Reginald F. Lewis Foundation. After a champagne toast in the new Research Center (the only time food or drink was allowed there!), a reception was graciously hosted in the beautiful salons of the J.P. Morgan Bank, Place Vendôme. I would like to thank Library Trustee Frederick H.S. Allen for making it possible for the Library to thank its generous donors in such an elegant fashion.

While the Library's generous donors can never be thanked enough, I would also like to thank some friends and Trustees whose intervention sometimes made the difference in the Library's receiving a very important contribution or not. Mrs. Curley's special support of the Library and its Research Center project was of extreme help and her active promotion of it made a significant difference. The work of Trustees Frederick H.S. Allen, Catherine Coste, Linda Emmet, Brenda Harper-Vandamme and Kandice Vettier is also greatly appreciated as it contributed directly to the success of the Library's biggest fundraising project ever. To all of you who gave or encouraged others to give, the Library is very grateful. In addition, I would like to thank Bob Grattan and the

ALP staff who ensured a smooth integration of the Research Center into the library operation.

The American Library in Paris' sixth annual Gala dinner was held at U.S. Ambassador and Mrs. Walter J.P. Curley's residence on May 21, 1992. New York Times Senior columnist Flora Lewis gave a witty talk about the journalistic interpretations of world events to the 150 guests. Gala Chairman Bob Gogel is to be congratulated on his second successful Gala. The Library would like to express its great appreciation to our sponsors whose generous support of this Gala Dinner accounts for one third of our annual contributions for general purposes: Alico, American Airlines, Gemini Consulting, Marwais and the International Herald Tribune who made an extra contribution of an American Library Special Edition containing come of Flora Lewis' notable editorials. The Library is also grateful to its devoted friends whose attendance of the Gala makes for a lovely evening and to those who cannot attend but whose contributions make for a financially successful event.

Our four Branch libraries are functioning well and our policy and agreements concerning the Branches are being studied and updated along with our regular Library projects. This is a big job involving a lot of travel, meetings and documentation and I thank Virginia Pilpoul and her able assistant, Catherine Coste deserve special thanks from the entire Board of Trustees for their work with the Branches. In the meantime, I salute the four Branches and say keep up the good work!

Obviously there are many other activities and contributions from friends and Trustees which cannot be named specifically here. You are all to be thanked for the many and varied ways in which you help the Library. With all of our hard work and enthusiasm, the Library will continue successfully with its present high standards of community service and its smooth advancement into the 21st century is assured.

U.S. Gifts and Bequests to the AMERICAN LIBRARY IN PARIS-USA FOUNDATION

The American Library in Paris-USA Foundation is a U.S. registered charity and all gifts to it are completely deductible for U.S. estate, inheritance and income tax purposes. The wording that follows is suitable to send to your attorney to make a gift. This wording could be simply incorporated either into a new Will or in amendment as a Codicil to your existing Will or an amendment to your Trust.

"I bequeath (or "My Trustee shall donate") to the American Library in Paris-USA Foundation, 306 South State Street, Dover, DE 19901, the Sum of ..." or "the following specific property..."

"I bequeath to the American Library in Paris-USA Foundation, 306 South State Street, Dover, DE 19901, ... (state the fraction you choose) of the residue of my estate."

or

"I bequeath the residue of my estate to the American Library in Paris-USA Foundation, 306 South State Street, Dover, DE 19901"
